# Answering women's legal questions about Victoria's public disclosure laws

Some victim-survivors of sexual assault have questions about the legal issues around telling their story or being identified publicly.

Women's Legal Service Victoria now provides free, confidential legal advice and referrals for women who want to know how the current laws affect them.

- The legal advice and referral line operates every weekday from 9am to 5pm.
- Our lawyers can advise individual women on how the current laws might affect them.
- Our lawyers are all women.
- Our lawyers work within a trauma-informed framework and specialise in legal issues arising from violence against women.
- Our lawyers can assist women with referrals to other services if appropriate.

# When should victim-survivors get legal help?

If you are a victim-survivor of sexual assault you should speak to a lawyer if:

- You would like to speak publicly about your experience
- You are concerned about the legal implications of speaking publicly

# What does the law currently say?

- In Victoria, the law puts limits on people's ability to speak publicly or publish information about a sexual assault.
- Publishing information includes posting on social media, writing an article, speaking at a public event or talking to the media.
- You can apply to the court for permission to publish information or speak publicly about a sexual assault.
- If you speak publicly or publish details of a sexual assault without getting the court's permission first you may be charged with an offence.
